**Signage**: the clerk to contact Highways as there is no sign for Ashley Close.

**Damage to The Green:** a number of people have complained about the damage by The Crossings but the owners have confirmed they will reinstate / replace back to the original status. Currently they have actually increased the size of the easement by  $1\frac{1}{2}$  yards from the green into the drive.

**The Croft pavement:** this has already been reported – clerk to chase.

**Memorial tree** – **The Leys:** brief discussion on planting a memorial tree, Cllr Mrs Kemball agreed to investigate and report back to councillors.
