FINANCIAL REGULATIONS

Adopted 2024-07-09

1. General

- 1.1 These Financial Regulations govern the financial management of the Council and may only be amended or varied by resolution of the Council. They are one of the governing documents of the Council and shall be observed in conjunction with the Standing Orders.
- 1.2 Councillors are expected to follow these regulations and not to entice any employee to breach them. Failure to follow these regulations brings the office of Councillor into disrepute.
- 1.3 Wilful breach of these regulations by an employee may result in disciplinary proceedings.
- 1.4 In these Financial Regulations:
- ◆ 'Accounts and Audit Regulations' means the regulations issued under Sections 32, 43(2) and 46 of the Local Audit and Accountability Act 2014, or any superseding legislation, and then in force, unless otherwise specified.
 - ◆ 'Approve' refers to an online action, allowing an electronic transaction to take place.
 - ◆ 'Authorise' refers to a decision by the Council to allow something to happen.
 - ◆ 'Proper practices' means those set out in *The Practitioners' Guide*.
 - ◆ '*Practitioners' Guide*' refers to the *Joint Panel on Accountability and Governance Practitioners' Guide* (JPAG) as published by the National Association of Local Councils (NALC).
 - ◆ 'Must' and **bold text** refer to a statutory obligation the Council cannot change.
 - ◆ 'Shall' refers to a non-statutory instruction by the Council to its members and staff.
- 1.5 The Clerk has been appointed as Responsible Financial Officer (RFO) and these regulations apply accordingly. The RFO:
- ◆ acts under the policy direction of the Council;
 - ◆ administers the financial affairs of the Council in accordance with all Acts, Regulations and proper practices;
 - ◆ determines on behalf of the Council its accounting records and control systems;
 - ◆ ensures the accounting control systems are observed;
 - ◆ ensures the accounting records are kept up to date;
 - ◆ seeks economy, efficiency and effectiveness in the use of Council resources; and
 - ◆ produces financial management information as required by the Council.
- 1.6 **The Council must not delegate any decision regarding:**
- ◆ **setting the final budget or the precept (council tax requirement);**
 - ◆ **the outcome of a review of the effectiveness of its internal controls;**
 - ◆ **approving accounting statements;**

- ◆ **approving an annual governance statement;**
- ◆ **borrowing;**
- ◆ **declaring eligibility for the General Power of Competence; and**
- ◆ **addressing recommendations from the internal or external auditors.**

1.7 In addition, the Council shall determine and regularly review the bank mandate for all Council bank accounts.

2. Risk Management and Internal Control

2.1 **The Council must ensure that it has a sound system of internal control, which delivers effective financial, operational and risk management.**

2.2 The Clerk shall prepare, for approval by the Council, a risk management policy covering all activities of the Council. This policy and consequential risk management arrangements shall be reviewed by the Council at least annually.

2.3 When considering any new activity, the Clerk shall prepare a draft risk assessment, including risk management proposals, for consideration by the Council.

2.4 **At least once a year, the Council must review the effectiveness of its system of internal control, before approving the Annual Governance Statement.**

2.5 **The accounting control systems determined by the RFO must include measures to:**

- ◆ **ensure that risk is appropriately managed;**
- ◆ **ensure the prompt, accurate recording of financial transactions;**
- ◆ **prevent and detect inaccuracy or fraud;**
- ◆ **allow the reconstitution of any lost records;**
- ◆ **identify the duties of officers dealing with transactions; and**
- ◆ **ensure division of responsibilities.**

2.6 At the end of each quarter, and at each financial year end, the Finance Councillor shall verify bank reconciliations (for all accounts) produced by the RFO. He/she shall sign and date the reconciliations and the original bank statements as evidence of this. This activity, including any exceptions, shall be reported to and noted by the Council.

2.7 Regular back-up copies shall be made of all Council records and stored securely either online or in a separate location. The Council shall put measures in place to ensure that the ability to access any Council record is not lost should an employee leave or be incapacitated for any reason.

3. Accounts and Audit

- 3.1 All accounting procedures and financial records of the Council shall be determined by the RFO in accordance with the Accounts and Audit Regulations.
- 3.2 **The accounting records determined by the RFO must be sufficient to explain the Council's transactions and to disclose its financial position with reasonably accuracy at any time. In particular, they must contain:**
- ◆ **day-to-day entries of all sums of money received and expended by the Council and the matters to which they relate; and**
 - ◆ **a record of the assets and liabilities of the Council.**
- 3.3 The accounting records shall be designed to facilitate the efficient preparation of the accounting statements in the Annual Governance and Accountability Return (AGAR).
- 3.4 The RFO shall complete and certify the annual Accounting Statements of the Council contained in the AGAR in accordance with proper practices, as soon as practicable after the end of the financial year. Having certified the Accounting Statements, the RFO shall submit them (with any related documents) to the Council, within the timescales required by the Accounts and Audit Regulations.
- 3.5 **The Council must ensure that there is an adequate and effective system of internal audit of its accounting records and internal control system in accordance with proper practices.**
- 3.6 **Any officer or member of the Council must make available such documents and records as the internal or external auditor consider necessary for the purpose of the audit** and shall, as directed by the Council, supply the RFO, internal auditor, or external auditor with such information and explanation as the Council considers necessary.
- 3.7 The internal auditor shall be appointed by the Council and shall carry out his/her work to evaluate the effectiveness of the Council's risk management, control and governance processes in accordance with proper practices specified in The Practitioners' Guide.
- 3.8 The Council shall ensure that the internal auditor:
- ◆ is competent and independent of the financial operations of the Council;
 - ◆ reports to the Council in writing, or in person, on a regular basis with a minimum of one written report during each financial year;
 - ◆ can demonstrate competence, objectivity and independence, free from any actual or perceived conflicts of interest, including those arising from family relationships; and
 - ◆ has no involvement in the management or control of the Council.

- 3.9 Internal or external auditors may not under any circumstances:
- ◆ perform any operational duties for the Council;
 - ◆ initiate or approve accounting transactions;
 - ◆ provide financial, legal or other advice including in relation to any future transactions; or
 - ◆ direct the activities of any Council employee, except to the extent that such employees have been appropriately assigned to assist the internal auditor.
- 3.10 For the avoidance of doubt, in relation to internal audit the terms 'independent' and 'independence' shall have the same meaning as described in The Practitioners Guide.
- 3.11 The RFO shall make arrangements for the exercise of electors' rights in relation to the accounts, including the opportunity to inspect the accounts, books, and vouchers and display or publish any notices and documents required by the Local Audit and Accountability Act 2014, or any superseding legislation, and the Accounts and Audit Regulations.
- 3.12 The RFO shall, without undue delay, bring to the attention of all councillors any correspondence or report from internal or external auditors.

4. Budget and Precept

- 4.1 **Before setting a precept, the Council must calculate its council tax requirement for each financial year by preparing and approving a budget, in accordance with The Local Government Finance Act 1992 or succeeding legislation.**
- 4.2 Budgets for salaries and wages, including employer contributions, shall be reviewed by the Council] at least annually in October for the following financial year and the final version shall be evidenced by a hard copy schedule signed by the Clerk and the Chair of the Council.
- 4.3 No later than November each year, the RFO shall prepare a draft budget with detailed estimates of all income and expenditure for the following financial year taking account of the lifespan of assets and cost implications of repair or replacement.
- 4.4 Unspent budgets for completed projects shall not be carried forward to a subsequent year. Unspent funds for partially completed projects may only be carried forward by placing them in an earmarked reserve with the formal approval of the full Council.
- 4.5 The draft budget, including any recommendations for the use or accumulation of reserves, shall be considered by the Finance Working Group and a recommendation made to the Council.

- 4.6 Having considered the proposed budget, the Council shall determine its council tax requirement by setting a budget. The Council shall set a precept for this amount no later than the end of January for the ensuing financial year.
- 4.7 **Any member with council tax unpaid for more than two months is prohibited from voting on the budget or precept by Section 106 of the Local Government Finance Act 1992 and must and must disclose at the start of the meeting that Section 106 applies to them.**
- 4.8 The RFO shall **issue the precept to the billing authority no later than the end of February** and supply each member with a copy of the agreed annual budget.
- 4.9 The agreed budget provides a basis for monitoring progress during the year by comparing actual spending and income against what was planned.
- 4.10 Any addition to, or withdrawal from, any earmarked reserve or the general reserve shall be agreed by the Council.
- 5. Procurement**
- 5.1 **Members and officers are responsible for obtaining value for money at all times.** Any officer procuring goods, services or works should ensure, as far as practicable, that the best available terms are obtained, usually by obtaining prices from several suppliers.
- 5.2 The RFO should verify the lawful nature of any proposed purchase before it is made and, in the case of new or infrequent purchases, should ensure that the legal power being used is reported to the meeting at which the order is authorised and also recorded in the minutes.
- 5.3 Every contract shall comply with Council Standing Orders and these Financial Regulations and no exceptions shall be made, except in an emergency.
- 5.4 **For a contract for the supply of goods, services or works where the estimated value will exceed the thresholds set by Parliament, the full requirements of The Public Contracts Regulations 2015 or any superseding legislation ('the Legislation'), must be followed in respect of the tendering, award and notification of that contract.**
- 5.5 Where the estimated value is below the Government threshold, the Council shall (with the exception of items listed in paragraph 6.12) obtain prices as below.
- 5.6 For contracts estimated to exceed £60,000 including VAT, the Clerk shall advertise an open invitation for tenders in compliance with any relevant provisions of the Legislation. Tenders shall be invited in accordance with the Appendix.

- 5.7 **For contracts estimated to be over £30,000 including VAT, the Council must comply with any requirements of the Legislation regarding the advertising of contract opportunities and the publication of notices about the award of contracts.**
- 5.8 For contracts greater than £3,000 excluding VAT the Clerk shall seek at least three fixed-price quotes.
- 5.9 Where the value is between £500 and £3,000 excluding VAT, the Clerk shall obtain three estimates which might include evidence of online prices, or recent prices from regular suppliers.
- 5.10 **Contracts must not be split into smaller lots to avoid compliance with these rules.**
- 5.11 The requirement to obtain competitive prices in these regulations need not apply to contracts that relate to the items below:
- ◆ specialist services, such as legal professionals acting in disputes;
 - ◆ repairs to, or parts for, existing machinery or equipment;
 - ◆ works, goods or services that constitute an extension of an existing contract;
 - ◆ goods or services that are only available from one supplier or are sold at a fixed price.
- 5.12 When applications are made to waive this financial regulation to enable a price to be negotiated without competition, the reason should be set out in a recommendation to the Council. Avoidance of competition is not a valid reason.
- 5.13 The Council shall not be obliged to accept the lowest or any tender, quote or estimate.
- 5.14 Individual purchases within an agreed budget for that type of expenditure may be authorised by:
- ◆ the Clerk, under delegated authority, for any items below £500 excluding VAT;
 - ◆ the Clerk, in consultation with the Chair of the Council, for any items below £1000 excluding VAT; and
 - ◆ the Council for all items over £1000.
- Such authorisation must be supported by a minute in the case of Council decisions or other auditable evidence trail.
- 5.15 No individual member, or informal group of members may issue an official order, unless instructed to do so in advance by a resolution of the Council, or make any contract on behalf of the Council.
- 5.16 No expenditure may be authorised that will exceed the budget for that type of expenditure other than by resolution of the Council except in an emergency.

- 5.17 In cases of serious risk to the delivery of Council services or to public safety on Council land, the Clerk may authorise expenditure of up to £300 excluding VAT on repair, replacement or other work that in his/her judgement is necessary, whether or not there is any budget for such expenditure. The Clerk shall report such action to the Chair as soon as possible and to the Council as soon as practicable thereafter.
- 5.18 No expenditure shall be authorised, no contract entered into or tender accepted in relation to any major project, unless the Council is satisfied that the necessary funds are available and, that where a loan is required, Government borrowing approval has been obtained first.
- 5.19 An official order or letter (including e-mail) shall be issued for all work, goods and services above £250 excluding VAT unless a formal contract is to be prepared or an official order would be inappropriate. Copies of orders shall be retained, along with evidence of receipt of goods.
- 5.20 Any ordering system can be misused and access to it shall be controlled by the RFO.

6. Banking and Payments

- 6.1 Council banking arrangements, including the bank mandate, shall be made by the RFO and authorised by the Council. The Council has resolved to bank with NatWest. The arrangements shall be reviewed annually for security and efficiency.
- 6.2 The Council must have safe and efficient arrangements for making payments, to safeguard against the possibility of fraud or error. Two members must be involved in any payment, by dual cheque signing. Even where a purchase has been authorised, the payment must also be authorised and only authorised payments shall be approved or signed to allow the funds to leave the Council's bank.
- 6.3 All invoices for payment must be examined for arithmetical accuracy, analysed to the appropriate expenditure heading and verified to confirm that the work, goods or services were received, checked and represent expenditure previously authorised by the Council before being certified by the RFO.
- 6.4 Personal payments (including salaries, wages, expenses and any payment made in relation to the termination of employment) may be summarised to avoid disclosing any personal information.
- 6.5 All payments shall be made by cheque, in accordance with a resolution of the Council, unless the Council resolves to use a different payment method.
- 6.6 For each financial year the RFO may draw up a schedule of regular payments due in relation to a continuing contract or obligation, such as salaries, PAYE, National

Insurance, pension contributions, regular maintenance contracts and similar items, which the Council may authorise in advance for the year.

- 6.7 A copy of this schedule of regular payments shall be signed by two members on each and every occasion when payment is made - to reduce the risk of duplicate payments.
- 6.8 A list of such payments shall be reported to the next appropriate meeting of the Council for information only.
- 6.9 The Clerk shall have delegated authority to authorise payments only in the following circumstances:
- ◆ any payments of up to £500 excluding VAT, within an agreed budget;
 - ◆ payments of up to £300 excluding VAT in cases of serious risk to the delivery of Council services or to public safety on Council land;
 - ◆ any payment necessary to avoid a charge under the Late Payment of Commercial Debts (Interest) Act 1998, or to comply with contractual terms, where the due date for payment is before the next scheduled meeting of the Council, where the Clerk certifies that there is no dispute or other reason to delay payment, provided that a list of such payments shall be submitted to the next appropriate meeting of Council; and
 - ◆ Fund transfers, following consultation with the Finance Councillor, within the Council banking arrangements up to the sum of £25,000 provided that a list of such transfers shall be submitted to the next appropriate meeting of Council.
- 6.10 The RFO shall present a schedule of payments requiring authorisation, forming part of the agenda for the meeting, together with the relevant invoices, to the Council. The Council shall review the schedule for compliance and, having satisfied itself, shall authorise payment by resolution. The authorised schedule shall be initialled immediately below the last item by the person chairing the meeting. A detailed list of all payments shall be disclosed within or as an attachment to the minutes of that meeting.

7. Electronic Payments

- 7.1 Where internet banking arrangements are made with any bank, the RFO shall be appointed as the Service Administrator. The bank mandate agreed by the Council shall identify the councillors who will be authorised to approve transactions on the accounts and a minimum of two signatories will be involved in any online approval process.
- 7.2 All authorised signatories, plus the RFO, shall have access to view Council accounts online.
- 7.3 Neither the RFO nor any councillor shall disclose any PIN or password, relevant to the Council and its banking, to anyone not authorised in writing by the Council.

7.4 Members and the RFO shall ensure that any computer used for Council financial business has adequate security, with anti-virus, anti-spyware and firewall software installed and regularly updated.

8. Cheque Payments

8.1 Cheques or orders for payment in accordance with a resolution or delegated decision shall be signed by two members.

8.2 A signatory having a family or business relationship with the beneficiary of a payment shall not, under normal circumstances, be a signatory to that payment.

8.3 To indicate agreement of the details on the cheque with the counterfoil and the invoice or similar documentation, the signatories shall also initial the cheque counterfoil and invoice.

8.4 Cheques or orders for payment shall not normally be presented for signature other than at, or immediately before or after a Council meeting. Any signatures obtained away from Council meetings shall be reported to the Council at the next convenient meeting.

9. Petty Cash

9.1 The Council will not maintain any form of cash float.

9.2 Any payments made in cash by the Clerk, for example for postage or minor stationery items, shall be refunded on a regular basis, at least quarterly.

10. Payment of Salaries and Allowances

10.1 **As an employer, the Council must make arrangements to comply with the statutory requirements of PAYE legislation.**

10.2 **Councillor allowances (where paid) are also liable to deduction of tax under PAYE rules and must be taxed correctly before payment.**

10.3 Salary rates shall be agreed by the Council. No changes shall be made to any employee's gross pay, emoluments, or terms and conditions of employment without the prior consent of the Council.

10.4 Payment of salaries shall be made, after deduction of tax, national insurance, pension contributions and any similar statutory or discretionary deductions, on the dates stipulated in employment contracts.

- 10.5 Deductions from salary shall be paid to the relevant bodies within the required timescales, provided that each payment is reported, as set out in these regulations above.
- 10.6 Each payment to employees of net salary and to the appropriate creditor of the statutory and discretionary deductions shall be recorded in a payroll control account or other separate confidential record, with the total of such payments each calendar month reported in the cashbook. Payroll reports will be reviewed by the Finance Councillor to ensure that the correct payments have been made.
- 10.7 Any termination payments shall be supported by a report to the Council, setting out a clear business case. Termination payments shall only be authorised by the full Council.
- 10.8 Before employing interim staff, the Council must consider a full business case.

11. Loans and Investments

- 11.1 Any application for Government approval to borrow money and subsequent arrangements for a loan must be authorised by the full Council and recorded in the minutes. All borrowing shall be in the name of the Council, after obtaining any necessary approval.
- 11.2 Any financial arrangement which does not require formal borrowing approval from the Secretary of State must be authorised by the full Council, following a written report on the value for money of the proposed transaction.

12. Income

- 12.1 The collection of all sums due to the Council shall be the responsibility of and under the supervision of the RFO.
- 12.2 The Council will review all fees and charges for services provided at least annually as part of the budget-setting process, following a report by the Clerk.
- 12.3 Any sums found to be irrecoverable and any bad debts shall be reported to the Council by the RFO and shall be written off in the year. The Council's approval shall be shown in the accounting records.
- 12.4 All sums received on behalf of the Council shall be deposited intact with the Council's bankers, with such frequency as the RFO considers necessary. The origin of each receipt shall clearly be recorded on the paying-in slip or other record.

12.5 The RFO shall ensure that VAT is correctly recorded in the Council accounting records. Any repayment claim under section 33 of the VAT Act 1994 shall be made at least annually at the end of the financial year.

13. Assets, Properties and Estates

13.1 The Clerk shall make arrangements for the safe custody of any and all title deeds and Land Registry Certificates of properties held by the Council.

13.2 The RFO shall ensure that an appropriate and accurate Register of Assets is kept up to date, with a record of all properties held by the Council, their location, extent, plan, reference, and purpose for which held, in accordance with Accounts and Audit Regulations.

13.3 The continued existence of tangible assets shown in the Register shall be verified at least annually, in conjunction with a health and safety inspection of assets.

13.4 No interest in land shall be purchased or otherwise acquired, sold, leased or otherwise disposed of without the authority of the Council, together with any other consents required by law. In each case a written report shall be provided to Council in respect of valuation and surveyed condition of the property (including matters such as planning permissions and covenants) together with a proper business case, including an adequate level of consultation with the electorate where required by law.

13.5 No tangible moveable property shall be purchased or otherwise acquired, sold, leased or otherwise disposed of, without the authority of the Council, together with any other consents required by law. In each case a written report shall be provided to Council with a full business case.

14. Insurance

14.1 The RFO shall keep a record of all insurances effected by the Council and the property and risks covered, reviewing these annually before the renewal date in conjunction with the Council's review of risk management.

14.2 The Clerk shall give prompt notification to the Council of all new risks, properties or vehicles which require to be insured and of any alterations affecting existing insurances.

14.3 The RFO shall be notified of any loss, liability, damage or event likely to lead to a claim, and shall report these to the Council at the next available meeting. The RFO shall negotiate all claims on the Council's insurers.

14.4 All appropriate members and employees of the Council shall be included in a suitable form of security or fidelity guarantee insurance which shall cover the maximum risk exposure as determined annually by the Council.

15. Suspension and Revision of Financial Regulations

15.1 The Council shall review these Financial Regulations annually. The Clerk shall monitor changes in legislation or proper practices and advise the Council of any need to amend these Financial Regulations.

15.2 The Council may, by resolution duly notified prior to the relevant meeting of Council, suspend any part of these Financial Regulations, provided that reasons for the suspension are recorded and that an assessment of the risks arising has been presented to all members. Suspension does not disapply any legislation or permit the Council to act unlawfully.

15.3 The Council may temporarily amend these Financial Regulations by a duly notified resolution, to cope with periods of absence, local government reorganisation, national restrictions or other exceptional circumstances.

Appendix: Tender Process

- 1) Any invitation to tender shall state the general nature of the intended contract and the Clerk shall obtain the necessary technical assistance to prepare a specification in appropriate cases.
- 2) The invitation shall in addition state that tenders must be addressed to the Clerk in the ordinary course of post unless an electronic tendering process has been agreed by the Council.
- 3) Where a postal process is used, each tendering firm shall be supplied with a specifically marked envelope in which the tender is to be sealed and remain sealed until the prescribed date for opening tenders for that contract. All sealed tenders shall be opened at the same time on the prescribed date by the Clerk in the presence of at least one member of Council.
- 4) Where an electronic tendering process is used, the Council shall use a specific e-mail address that will be monitored to ensure that nobody accesses any tender before the expiry of the deadline for submission.
- 5) Any invitation to tender issued under this regulation shall be subject to Standing Order 18 and shall refer to the terms of the Bribery Act 2010.
- 6) Where the Council does not accept any tender, quote or estimate, the work is not allocated and the Council requires further pricing, no person shall be permitted to submit a later tender, estimate or quote who was present when the original decision-making process was being undertaken.
